<b>Purposes for which we process personal data:</b>	<ul style="list-style-type: none"> <li>• Administering your application for membership of the Club</li> <li>• Administering bookings and attendance at sessions</li> <li>• Dealing with medical needs/specific requirements</li> <li>• Supporting the delivery of cricket sessions</li> <li>• For training and competition entry</li> <li>• Reporting of participation and of any incidents and of figures and trends (including equality and inclusion information)</li> <li>• Quality and improvement monitoring</li> </ul>

<p><b>Who we will disclose your personal data to:</b></p>	<ul style="list-style-type: none"> <li>• Cricket leagues, where you have been nominated for/agree to play for a league</li> <li>• The England &amp; Wales Cricket Board (ECB) where you are registered for or express an interest in an ECB programme</li> <li>• The County Cricket Board that support our Club, whose programmes you have registered for</li> <li>• Coaches and other volunteers for administrating training and other sessions</li> <li>• The Club’s Membership Secretary</li> <li>• Social Media and/or the Club’s website</li> <li>• Local press</li> </ul>
<p><b>Legal basis for processing your personal data:</b></p>	<ul style="list-style-type: none"> <li>• <b>For administration and programme delivery</b> – that it is necessary to fulfil the contract that you are going to enter or have entered with Brymbo Cricket Club</li> <li>• <b>For dealing with medical needs</b> – that you have given your explicit consent or in your vital interests</li> <li>• <b>In all other cases</b> – that it is necessary for our legitimate interests which are to build a programme to encourage participation in cricket and does not prejudice or harm your rights or freedoms.</li> </ul>
<p><b>Your right to withdraw consent:</b></p>	<ul style="list-style-type: none"> <li>• Where you have given your consent to any processing of personal data, you have the right to withdraw that consent at any time.</li> <li>• If you do, it will not affect the lawfulness of any processing for which we had consent prior to your withdrawing it.</li> </ul>
<p><b>Location of your personal data:</b></p>	<ul style="list-style-type: none"> <li>• The Club will store your personal data securely and within the European Economic area</li> </ul>
<p><b>How long we will keep your personal data for:</b></p>	<ul style="list-style-type: none"> <li>• We will not retain your personal data for longer than is reasonable and necessary for the purposes for which it was collected.</li> <li>• We shall retain your personal data for such time as you are registered with Brymbo Cricket Club as a member.</li> <li>• After you cease to be a member of Brymbo Cricket Club or play an active part in the club, we shall delete your data, but keep a truncated record for the archives of the club.</li> <li>• Details are available from the Club’s secretary</li> </ul>

<b>Your rights in respect of your personal data:</b>	<ul style="list-style-type: none"> <li>You have the right of access to your personal data and in some cases to require us to restrict, erase or rectify it; object to our processing it and the right of data portability</li> </ul>
